



## GENERAL PROCUREMENT NOTICE RELATED TO THE COMPACT PROCUREMENT PLAN N°13 BIS

The Government of Benin acting through its representative - MCA-Benin II, has received grant funding amounting to Three Hundred and Seventy-Five Million United States Dollars (US \$375,000,000) from the Millennium Challenge Corporation ("MCC"), an agency of the United States Government, to enable MCA-Benin II to implement the MCC Compact (the "Program") and achieve its objectives. In the framework of this Program, it intends to apply part of the proceeds of the funds to payments for contracts for goods, works and services. The Government of Benin's contribution to the Program is Twenty-Eight Million One Hundred and Twenty-Five Thousand United States Dollars (US \$28,125,000).

MCC's funding is appropriated by the U.S. Congress and obligated to the Compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Contractors/Consultants/Suppliers by the US Treasury.

The Procurement Plan N°13 Bis that follows the Compact's entry into force on June 22, 2017 covers the period of July 2021 to June 2022. The activities that comprise the plan are as follows:

<b>Procurement of works</b> for the Electricity Distribution Project (EDP) of the MCA-Benin II Compact including: <ul style="list-style-type: none"><li>Works for the completion of the buildings to house the dispatch center (main and back-up) + Equipment</li></ul>
<b>Procurement of Consultant Services</b>
<b>Individuals Consultants</b> for the Policy Reform and Institutional Strengthening Project (PRISP) and Direction of Administration and Finance (DAF) of the MCA-Benin II Compact, including: <b>Projet "Policy Reform and Institutional Strengthening Project" (PRISP):</b> <ul style="list-style-type: none"><li>Recruitment of an individual consultant for the training of the Ministry of Energy staff on strategic planning and the sectoral vision of the Ministry of Energy and establishment of a budget platform PTF ONG and GoB.</li></ul> <b>Direction of Administration and Finance (DAF) :</b> <ul style="list-style-type: none"><li>Recruitment of individual consultants for technical assistance and support to MCA-Benin II.</li></ul>

The Contracts for Goods, Works and Services financed under the Program will be implemented according to the principles, rules and procedures set out in the MCC Program Procurement Guidelines which can be found at the MCC website at <https://www.mcc.gov/resources/doc/program-procurement-guidelines>.

The procurements are open to all bidders/consultants from eligible source countries as defined in the MCC PPG.
