



✓ GENERAL PROCUREMENT NOTICE N°2 Amendment N°1

The Government of **Benin** has received grant funding of Three Hundred and Seventy Five Million United States Dollars (USD 375,000,000) from the Millennium Challenge Corporation (“MCC”) of the United States Government to enable the Government of Benin to implement this program and achieve the objectives of the MCC Grant (Compact II), and it intends to apply parts of the proceeds of the funds to payments for Contracts for Goods, Works and Services.

- Completion of topographic survey and securing four sites selected for solar power plants.
