



AMENDMENT #1 To RFP N° PP1-UCF/FDP-02

SELECTION OF OFF GRID CLEAN ENERGY FACILITY MANAGER

Subject: The purpose of this Amendment is to:

- I. extend the submission deadline of proposals to October 28, 2016 ;
- II. extend the deadlines to receive and to respond to the clarification questions.

Therefore, the Request for Proposal is amended as follows:

A. Letter of Invitation for Proposals (IFP), page v, 3rd paragraph:

Delete:

“Proposals must be delivered to the address and in the manner specified in the PDS ITC 17.5, **no later than September 29th, 2016 at 10:00 a.m. local time in Benin.**”

And replace by:

“Proposals must be delivered to the address and in the manner specified in the PDS ITC 17.5, **no later than October 28th, 2016 at 10:00 a.m. local time in Benin.**”

B. Part 1 Proposal and Selection Procedures, Section II : Proposal Data Sheet, B - Contents of the RFP, sub-clause ITC 8.1, page 33, 1st paragraph:

Delete:

“Clarifications may be requested by e-mail not later than **fifteen (15) business days e.g., September 8th, 2016** before the deadline for submission of the Proposals, so that responses can be issued to all Consultants not later than **ten (10) business days e.g., September 15th, 2016** prior to the deadline for submission of Proposals”.

And replace by:

“Clarifications may be requested by e-mail not later than **fifteen (15) business days e.g., October 7th, 2016** before the deadline for submission of the Proposals, so that responses can be issued to all Consultants not later than **ten (10) business days e.g., October 14th, 2016** prior to the deadline for submission of Proposals”.



C. Part 1 Section Instruction to Consultant, II : Proposal Data Sheet, Submission and Opening of Proposals

- Sub-clause ITC 17.7, page 37

Delete:

"Do NOT Open Before 10:00 a.m. local time on September 29th, 2016. On or after 10:00 a.m. local time on September 29th, 2016, Open ONLY In Presence of the Official Appointed."

And replace by:

"Do NOT Open Before 10:00 a.m. local time on October 28th, 2016. On or after 10:00 a.m. local time on October 28th, 2016, Open ONLY In Presence of the Official Appointed."

- Sub-clause ITC 18.1, page 37

Delete:

"Proposals must be submitted no later than 10:00 a.m. local time of Cotonou, Benin on September 29th, 2016."

And replace by:

"Proposals must be submitted no later than 10:00 a.m. local time of Cotonou, Benin on October 28th, 2016."

- Sub-clause ITC 20.1, page 37

Delete:

"The Proposal opening shall take place at Immeuble KOUGBLENOU, 3^{ème} étage, Domaine de l'OCBN, Derrière la Compagnie Territoriale de Gendarmerie du Littoral on September 29th, 2016 at 10:15 am Cotonou time, Benin."

And replace by:

"The Proposal opening shall take place at Immeuble KOUGBLENOU, 3^{ème} étage, Domaine de l'OCBN, Derrière la Compagnie Territoriale de Gendarmerie du Littoral on October 28th, 2016."

All the clauses of the initial bidding document which are not modified with this addendum remain valid.
