



**AMENDMENT #2**

**To RFP N° PP2-CIF-ESP-01**

**Selection of Consultant for Hazardous Materials Assessment**

**Subject:** The purpose of this Amendment is to:

- I. Extend the submission deadline of proposals to January 20, 2017;
- II. Extend the deadlines to respond to the clarification question.

Therefore, the Request for Proposal and its amendment N°1 are amended as follows:

**I. Extension of the submission deadline, page 1 of the amendment N°1 of the RFP**

**Delete:**

"Proposals must be delivered to the address and in the manner specified in the PDS ITC 17.5, no later than **January 09, 2017 at 10:00 a.m. local time in Benin**".

**And replace by:**

"Proposals must be delivered to the address and in the manner specified in the PDS ITC 17.5, no later than **January 20, 2017 at 10:00 a.m. local time in Benin**".

**II. Submission and Opening of Proposals, pages 1 and 2 of the amendment N°1 of the RFP**

**Sub-clause ITC 17.7**

**Delete:**

"Do NOT Open Before **10:00 a.m. local time on January 09, 2017**. On or after **10:00 a.m. local time on January 09, 2017**, Open ONLY In Presence of the Official Appointed."

**And replace by:**

"Do NOT Open Before **10:00 a.m. local time on January 20, 2017**. On or after **10:00 a.m. local time on January 20, 2017**, Open ONLY In Presence of the Official Appointed."

**- Sub-clause ITC 18.1**

**Delete:**

"Proposals must be submitted no later than **10:00 a.m. local time of Cotonou, Benin on January 09, 2017**."



***And replace by:***

**"Proposals must be submitted no later than 10:00 a.m. local time of Cotonou, Benin on January 20, 2017."**

**- Sub-clause ITC 20.1**

***Delete:***

**"The Proposal opening shall take place at Immeuble KOUGBLENOU, 3<sup>ème</sup> étage, Domaine de l'OCBN, Derrière la Compagnie Territoriale de Gendarmerie du Littoral on January 09, 2017 at 10:15 am Cotonou time, Benin."**

***And replace by:***

**"The Proposal opening shall take place at Immeuble KOUGBLENOU, 3<sup>ème</sup> étage, Domaine de l'OCBN, Derrière la Compagnie Territoriale de Gendarmerie du Littoral on January 20, 2017 at 10:15 am Cotonou time, Benin."**

**III. Extension of the deadline to respond to the clarification questions**

**- Sub-clause ITC 8.1**

***Delete:***


**"Clarifications may be requested by e-mail not later than fifteen (15) business days e.g., December 19, 2016 before the deadline for submission of the Proposals, so that responses can be issued to all Consultants not later than ten (10) business days e.g., December 26, 2016 prior to the deadline for submission of Proposal".**

***And replace by:***

**"Clarifications may be requested by e-mail not later than December 19, 2016, so that responses can be issued to all Consultants not later than January 6<sup>th</sup>, 2017".**

***All the clauses of the initial bidding document and its amendment N°1 which are not modified with this addendum remain valid.***
