Subject:

The purpose of this Amendment is to:

- extend the submission deadline of proposals to March 1st, 2017
- extend the deadlines to receive clarification questions.

Therefore, the Request for Proposal is amended as follows:

A. Extension of the submission deadline, page 1 of the amendment N°1 of the RFP

Delete:

"Proposals must be delivered to the address and in the manner specified in the PDS ITC 17.5, no later than **February 15, 2017 at 10:00 a.m. local time in Benin**".

And replace by:

"Proposals must be delivered to the address and in the manner specified in the PDS ITC 17.5, no later than **March 1**st, **2017 at 10:00 a.m. local time in Benin**".

B. Submission and Opening of Proposals, pages 1 and 2 of the amendment N°1 of the RFP

- Sub-clause ITC 17.7

Delete:

"Do NOT Open Before 10:00 a.m. local time on February 15, 2017. On or after 10:00 a.m. local time on January 31, 2017. Open ONLY In Presence of the Official Appointed."

And replace by:

"Do NOT Open Before **10:00 a.m. local time on March 1**st, **2017.** On or after **10:00 a.m. local time on March 1**st, **2017**. Open ONLY In Presence of the Official Appointed."

- Sub-clause ITC 18.1

Delete:

"Proposals must be submitted no later than 10:00 a.m. local time of Cotonou, Benin on February 15, 2017."

And replace by:

"Proposals must be submitted no later than 10:00 a.m. local time of Cotonou, Benin on March 1st, 2017.-"

- Sub-clause ITC 20.1

Delete:

"The Proposal opening shall take place at Immeuble KOUGBLENOU, 3^{ème} étage, Domaine de l'OCBN, Derrière la Compagnie Territoriale de Gendarmerie du Littoral on February 15, 2017 at 10:15 am Cotonou time, Benin."

And replace by:

"The Proposal opening shall take place at Immeuble KOUGBLENOU, 3^{ème} étage, Domaine de l'OCBN, Derrière la Compagnie Territoriale de Gendarmerie du Littoral on March 1st, 2017 at 10:15 am Cotonou time, Benin."

- C. Extension of the deadline to receive clarification questions
- Sub-clause ITC 8.1, page 33 of the RFP

Delete:

"Clarifications may be requested by e-mail not later than **fifteen (15) business** days **e.g., January 11, 2017** before the deadline for submission of the Proposals, so that responses can be issued to all Consultants not later than **ten (10) business** days **e.g., January 18, 2017** prior to the deadline for submission of Proposals".

And replace by.

"Clarifications may be requested by e-mail not later than **February 8th**, **2016**, so that responses can be issued to all Consultants not later than **February 17th**, **2017**".

All the clauses of the initial bidding document and its amendment N°1 which are not modified with this addendum remain valid.
